**FINAL JUDGMENT FOR DEFENDANTS, ADVANCE STORES COMPANY, INC.,
CAROL BLOUNT and ARI FLEET LT**

(d) The Plaintiff, NOEL VELASQUEZ, 3020 River Grove Drive, Tampa, FL 33610, shall take nothing by this action against the Defendant, ARI FLEET LT, 4001 Leadenhall Drive, Mt. Laurel, NJ 08054, and;

(e) The Defendant, ADVANCE STORES COMPANY, INC., 5008 Airport Road, Roanoke, VA 24012, shall recover from the Plaintiff, NOEL VELASQUEZ, 3023 River Grove Drive, Tampa, FL 33610, its' costs in the amount of \$15,072.54 that shall bear interest at the rate of 5.72% for which let execution issue.
